ELIGIBILITY:

The Sandy Springs Rotary Foundation welcomes applications by high school seniors who live within the City of Sandy Springs, Georgia and who attend a high school located within the city limits of the City of Sandy Springs, Georgia. Applicants must meet the following criteria.

- Be a high school senior with plans to enter college in 2025
- Permanent residents of the City of Sandy Springs, Georgia attending a high school within the City of Sandy Springs, Georgia
- Be eligible to attend a accredited two- or four-year college, university or technical school with a full time course of study
- Be a legal U.S. resident
- Submit a completed application by the deadline above.
- Provide the Sandy Springs Rotary Foundation, Inc. with the name of the school that you plan to attend.
- Students must complete the application form by themselves, except for the financial data section required of the parents/guardians.
- Financial need is a consideration in the application process.
- Recipients must attend accredited not-for-profit universities, colleges and/or higher education institutions & technical schools. Scholarship funds will not be paid to "for-profit" enterprises.

The Sandy Springs Rotary Foundation, Inc. celebrates and encourages young adults who embrace Rotary International's motto of **"Service Above Self"** and who exhibit exemplary academic, community service and leadership qualities. Many of the recipients have exhibited leadership qualities while participating in their high school's Interact Club.

The Dan Keels Scholarship is a scholarship program established in honor of the late Dan Keels who, as a member of the Rotary Club of Sandy Springs and as Chaplain of Northside Hospital, gave extensively to his community throughout his lifetime and inspired people through his lifetime of community service.

Typically, multiple Dan Keels Scholarships in an amount between \$2,000 and \$2,500 are awarded each year. The Sandy Springs Rotary Foundation, Inc. reserves the right to adjust the number of scholarships and their amount.
